



Daylight Savings Time - "Spring Forward"

If you live for those extra hours of daylight in the afternoons - don't forget to set your clocks **one hour ahead** on **March 8**th at (2 a.m.)!

This is also a great date to use as a reminder to replace batteries in your smoke and carbon monoxide detectors.

Please know that the Board and Management team are working diligently through all legal means to achieve a resolution.

Long-Term & Overflow Parking

We now have two designated long-term parking areas:

- Our 1st long-term parking area is directly across from Building 9.
 Please use the 2 parking spaces to the right of the "Long-Term Parking" sign. The other spaces to the left of the sign will now be used for normal overflow and/or visitor parking.
- Our 2nd long-term parking area is across from Building 3. The 4
 designated parking spaces are to the left of the "Long-Term Parking"
 sign. The other spaces to the right of the sign are for normal
 overflow and/or visitor parking.

Please be mindful of leaving the long-term spaces for our out-of-town travelers so they may enjoy their time away without worry of their vehicle hindering snow removal.

Also, please be very mindful of your neighbors when you choose to forgo your assigned parking spot - and park instead in a space located in an overflow parking area. These spaces are very limited - and please remember - overflow parking is primarily meant for residents with a second vehicle, visitors and also contractors.

Holiday Decorating - Reminder

 Holiday decorations are accepted 15 days before and 15 days after the holiday.

For Christmas, it is fine for decorating to begin right after Thanksgiving.

- It is ok to decorate your deck area and your immediate entrance area.
 It is not ok to go beyond your immediate area or off the deck.
- Good judgement is expected when choosing your holiday decorations.
- Be mindful of your neighbors and community safety.

BECAUSE YOU ASKED...

- PODS/Self Storage Containers: Yes you need to contact our management company before delivery of the container. There are size limits and area of placement limitations. Management will need to know the intended length of stay before approval can be made.
- Selling Your Condo: Yes you need to inform our management company 30 days prior. This is per our By-Laws - Article 10.01B
- New Tenants to Your Unit if Renting: Yes you need to contact management and provide them with all required information (lease, renters name and contact info, vehicle info, etc.)
- Help Moving Your Car during the Snow Removal Process: Yes please let Kelly at Edgewater know if you are in need of help moving your car so alternate arrangements can be made to assist you.
- Getting a New Pet: Yes you need to contact management prior to getting a new pet. This requirement is per our By-Laws - Section 13.03.

Please be a responsible pet owner!

- Several residents have complained about dog waste not being picked up and disposed of properly. As a courtesy to all of our residents (and pets), please remember you must pick up after them - it's the law!
- Also dogs are NOT allowed to roam freely outside of their condo.
 This is also part of the Dog Control Ordinance within the Town of Halfmoon and violators will be prosecuted.
- Residents affected by an irresponsible dog owner may file a complaint with the Town of Halfmoon's Animal Control division. Below is their website address:

- Once an official complaint has been filed they will be able to investigate and take action.
- To assist pet owners who may have *accidentally* forgotten their disposal bag, we have provided 3 dispensers of disposable bags, conveniently located along Monmouth Way.
